

# Junior Program Terms and Conditions

By making enrolling in the program, I accept the following terms and conditions.

## **Definitions**

**Facility** means the entity which is responsible for the conduct of the program (Institute of Golf). As the context requires Facility also includes the location at or from which the National Programs will be conducted (Collier Park Golf Course).

**GA** means Golf Australia Limited.

Golf Organisation means and includes GA, its members, the Facility and their respective directors, officers, members, servants, or agents.

**Participation** means performing or participating in any capacity in any activity in the Program.

**Program** means the MyGolf Program conducted by and at the Facility.

## **I acknowledge that:**

I can be exposed to certain risks during Participation including but not limited to physical exertion, contact with equipment, wind, and weather conditions. I acknowledge that accidents can and often do happen which may result in me being injured or even killed, or my property being damaged. I have voluntarily read and understood this warning and accept and assume the inherent risks in Participation.

I am medically, mentally, and physically fit and able to Participate in the Program. I am not and must not be a danger to myself or to the health and safety of others. I will immediately notify the Facility in writing of any change to my medical condition, fitness, and ability to participate.

I consent to GA and the Facility using, disclosing, and storing my personal information in accordance with the GA and/or Facility Privacy Policies ([www.golf.org.au/privacy-policy](http://www.golf.org.au/privacy-policy)). I understand that the information I have provided in this form is necessary for the proper management of the Program, administration of Golf and related activities in Australia. The information is collected in accordance with GA Privacy Policy.



## Junior Program Terms and Conditions

GA and/or the Facility may share my information with other Golf Organisations in accordance with the Privacy Policy and it may also be used to notify me of other events, news, and to offer the provision of services, including by third-party providers, to me. I understand that the Privacy Policy contains information about how I may access, and request correction of my personal information held by GA and/or the Facility or make a complaint about the handling of my personal information and provides information about how a complaint will be dealt with by GA and/or the Facility. If the information is not provided my application may be rejected. I acknowledge that if I do not wish to receive promotional material from Golf Organisation sponsors and third parties I may advise in writing or via the opt-out process provided in the relevant communication.

GA has in place certain insurance which cover my Participation. I acknowledge I can also affect and maintain my own insurance in respect of health insurance, personal injury and/or public liability to whatever value I consider necessary.

I consent to GA and the Facility, using my name, image, likeness, and my performance in the Participation at any time to promote the Objects of GA and/or the Facility, by any form of media. I waive any rights I might have to or in such use of my name, image or likeness by GA or the Facility.

**Bookings and Payment** - Full payment is made prior to the commencement of the course. Bookings are subject to availability. All bookings will be confirmed prior to commencement.

**Inclement Weather** - Where possible an alternative venue will be prearranged prior to commencement. Should this be unavailable, a makeup class will be arranged later.

**Injuries/ Sickness** - If illness or injury impacts the pupil long-term, contact Institute of Golf to organise a hold on the account and use of package inclusions later.
